- ★ Knox residents already took a pay cut when their social security tax increased by 44%!
- ★ Property taxes go to salaries and benefits of government employees.
- ★ Median household income for area residents is only \$38,961, 20% less than the state average.
 - Area residents are struggling with 12.3% unemployment

*Based on an average home value of \$99,400

About 80% of the local taxes go to salaries and benefits of government employees.

Polls open from 6am to 6pm on Tuesday, May 7, 2013.




