

TO STOP THE 1% SALES TAX INCREASE

- Shall a retailers' occupation tax and a service occupation tax (commonly referred to as a "sales tax") be imposed in the County of White, Illinois, at a rate of 1% to be used exclusively for school facility purposes?

- ★ Government schools need to live within their means and cut expenses when state revenue is cut
- ★ Raising sales taxes will drive local customers to neighboring communities where taxes are lower
- ★ It's not 'for the children'; it will be used to 'free up' money previously budgeted for buildings and maintenance in order to prop up the lavish, gold-plated pensions and salaries!
- ★ Property taxes in Illinois are the 2nd highest in the nation and should be adequate to fund schools

75% to 80% of local taxes go to fund salaries and benefits of government employees.
