- Shall the limiting rate under the Property Tax Extension Limitation Law for Berwyn South School District Number 100, Cook County, Illinois be increased by an additional amount equal to 0.60% above the limiting rate for levy year 2015 for any purpose of said School District and be equal to 4.195% of the equalized assessed value of the taxable property therein for levy year 2017?
  - ★ Voters defeated Berwyn South SD 100's last property tax increase referendum 3 years ago, rejecting the property tax increase by 79%.
  - ★ Voters are tired of property tax hikes. Taxpayers also rejected the most recent bond referendum for Berwyn South SD 100 3 years ago.
  - ★ The referendum would increase District 100 property taxes by \$2.2 million in the district, roughly a 17% increase in property taxes.
  - Last year, Berwyn South SD 100 collected \$13.3 million in property taxes.
