“ Shall the limiting rate under the Property Tax Extension Limitation Law for Evanston/Skokie Community Consolidated School District Number 65, Cook County, Illinois be increased by an additional amount equal to 0.595% above the limiting rate for school purposes for levy year 2015 and be equal to 4.166% of the equalized assessed value of the taxable property therein for levy year 2016? ”

- ★ Supt. Paul Goren has said the district has nearly 20 percent of its operating budget in reserve for "rainy day" funds.
- ★ According to the School District 65, more than 80% of its revenue comes from property taxes.
- ★ Government bureaucrats are trying to pass a property tax increase referendum, which will increase your property taxes by more than \$450 annually for an average home in Evanston/Skokie School District 65 valued at \$300,000.
