“ Shall the limiting rate under the Property Tax Extension Limitation Law for Oak Park School District Number 97, Cook County, Illinois, be increased by an additional amount equal to 1.000% above the limiting rate for school purposes for levy year 2015 and be equal to 4.982% of the equalized assessed value of the taxable property therein for levy year 2016? ”

“ Shall the Board of Education of Oak Park School District Number 97, Cook County, Illinois, improve the sites of, build and equip additions to, and alter, repair and equip school buildings of said School District and issue bonds of said School District to the amount of \$57,500,000 for the purpose of paying the costs thereof? ”

- ★ Last year's taxes increased 7.5 percent due to a property tax hike for the high school.
- ★ Oak Park SD 97 wants to raise your property taxes by another \$13.3 million.
- ★ Issuing new bonds will raise your property taxes by \$57,500,000 for the bond principle. Property taxes will also be raised by millions of more dollars to pay interest on the bonds.
- ★ Property taxes for average homeowners will increase by more than \$700 annually.
