ON A \$210 PROPERTY TAX INCREASE REFERENDUM

Shall the limiting rate under the Property Tax Extension Limitation Law for the Village of Steger, Counties of Cook and Will, Illinois, be increased by an additional amount equal to 0.5455% above the limiting rate for any purpose of said Village for levy year 2019 and be equal to 2.5355% of the equalized assessed value of the taxable property therein for levy year 2021.....

- ★ Increases property taxes \$182/yr. for every \$100,000 of home value.
- ★ Who raises taxes during a pandemic?
- ★ Illinois Unemployment Rate is 7.6% and climbing.
- ★ Will government employees take a pay cut or wage freeze?
