# **EXECUTIVE SUMMARY**

This is the 16th biennial, non-partisan Illinois Tax Survey compiled by Taxpayers United of America (TUA). For 39 years, TUA has educated taxpayers while publicizing all significant tax and spending increases voted on by the Illinois General Assembly. This edition analyzes the 98th General Assembly of Illinois.

The most notable bill to come out of this session was SB 1, the half-hearted pension reform legislation that has since been ruled unconstitutional by the Illinois Supreme Court. This bill, sponsored by the leadership of both parties in the legislature, was a pathetic attempt at reforming the unsustainable government pensions in Illinois. Regardless of the minor improvements, the fact remains that if SB 1 was upheld, Illinois taxpayers would still remain on the hook for billions upon billions of dollars in unfunded government pension liabilities, making it that much more difficult to enact true reform that removes the burden of funding lavish government employee pensions from the backs of taxpayers.

Speaking of taxpayers getting fleeced by politicians, Illinois taxpayers need not look any further than SB 274. This bill is a perfect example of bureaucratic self-preservation, whereby the Illinois General Assembly exempted their own budget from salary and operating expense reductions for future sessions, even if the proper annual budget appropriations aren't passed.

The dreaded Amazon Tax was proposed and killed a few times before its final passage this session as SB 352. Not only does this bill force retailers to collect a new 6.25% sales tax affecting online retailers and their customers, but this new sales tax simply diverts more money from the productive sector of the economy into the coffers of the most destructive sector of the economy: the government. For Illinois taxpayers, these tax dollars are just funneled into the bottomless pit better known as the unsustainable government pension system.

A roll call of every legislator and how they voted on each significant tax or spending bill surveyed for this session begins on page 5. Legislators' scores are normalized and range from 0% to 100%, indicating how often they supported taxpayers by voting against tax and spending increases. The best scoring legislators voted against all tax and spending increases and are included on the list of Taxpayers' Friends on page 6, while those who most often voted against taxpayers are included on the list of Taxpayers' Enemies on page 7-8. TUA has used the same methodology to evaluate each lawmaker's record since publishing its first Tax Survey in 1983.

## TAX INCREASES

SB 352 — The 2014 Online Highway Robbery Act Better known as the Amazon Tax, this legislation forces retailers to collect Illinois' 6.25% sales tax online if they are based out-of-state and are determined by the arbitrary dictates of bureaucrats to have a taxable presence within Illinois.

Sponsored in the Senate by Toi W. Hutchinson (D-40, Chicago Heights). Sponsored in the House by Majority Leader Barbara Flynn Currie (D-25, Chicago).

Passed by the Senate May 23, 2014. Passed by the House May 30, 2014. Signed by Gov. Pat Quinn (D) August 26, 2014.

## HB 1522 -- Rain Tax for DuPage and Peoria Counties

Creates meddlesome planning committees that will allow government busybodies to implement their new stormwater management policies. Gives bureaucrats the power to assess taxes on any piece of real property. The county boards also have the discretion to impose a brand new tax on property owners.

Sponsored in the House by Mike Fortner (R-49, West Chicago), Al Riley (D-38, Hazel Crest), Ron Sandack (R-81, Downers Grove), Darlene J. Senger (R-41, Naperville),

and Al Riley (D-38, Naperville). Sponsored in the Senate by David Koehler (D-46, Peoria) and Linda Holmes (D-42, Aurora).

Passed by the House March 15, 2013. Passed by the Senate May 16, 2013. Signed by Gov. Pat Quinn (D) August 13, 2013.

### SB 1922 -- Chicago Government Pension Bailout Bill

This is a massive bailout of two Chicago government pension funds with taxpayer dollars: Municipal Employees' Annuity and Benefit Fund of Chicago, and Laborers' and Retirement Board Employees' Annuity and Benefit Fund.

Chicago taxpayers will be forced to nearly quadruple their payments of tax dollars over time, from \$177 million in 2014 to more than \$650 million in 2020. Chicago taxpayers would now be liable for any shortfall resulting from nonpayment by the pension funds.

As it stands currently, the city and taxpayers are not legally obligated to save the failing funds. The bill does not reduce government pensions and does not increase their retirement age, even though it does raise employee contributions by 29% and reduces cost-of-living benefits in exchange for taxpayers bailing out the funds.

Sponsored in the Senate by Kwame Raoul (D-13, Chicago) and in the House by Speaker Michael J. Madigan (D-22, Chicago).

Passed by the Senate April 18, 2013. Passed by the House April 8, 2014. Signed by Gov. Patrick Quinn (D) June 9, 2014. Currently being litigated.

**SB 2758** — **Bureaucrat-Controlled Retirement Program** Establishes a retirement savings program with an automatic enrollment payroll-deduction IRA, with the stated purpose of promoting greater retirement savings for private-sector employees, but program funds will be administered by a board consisting mostly of state politicians. Politically-connected individuals and firms can be expected to provide investment and other services, and handle taxpayers' savings.

Sponsored in the Senate by Don Harmon (D 39, Oak

Park) and Dan Kotowski (D-28, Park Ridge) and in the House by Kathleen Willis (D-77, Northlake) and Litesa E. Wallace (D-67, Rockford).

Passed by the Senate April 9, 2014. Passed by the House December 2, 2014. Signed by Gov. Patrick Quinn (D) January 5, 2015.

#### SB 3341 -- Government Debt Without Referendum

**Act** This property tax increase legislation amends the Conservation District Act to allow a district to acquire property, incur debt, and issue and sell bonds without a property tax increase referendum. The taxpayers of Illinois do not need government officials to further burden their wallets by raking up enormous debts to fund projects at the whims of bureaucrats.

Sponsored in the Senate by Pamela J. Althoff (R-32, McHenry) and Karen McConnaughay (R-33, West Dundee) and in the House by Michael W. Tryon (R-66, Crystal Lake) and Ann Williams (D-11, Chicago).

Passed by the Senate April 7, 2014. Passed by the House December 3, 2014. Signed by Gov. Patrick Quinn (D) January 9, 2015.

## **SPENDING INCREASES**

### SB 1 -- The "Almost" Pension Reform Bill

This is the weak pension reform bill that reduces annual cost-of-living adjustments for retiree benefits; increases some government employees' retirement age; caps government employees' salaries for consideration of their pension payments; increases taxpayer subsidies to fund government pensions; provides stronger guarantee that taxpayers must pay all benefits; and does absolutely nothing to eliminate unfunded government pension liabilities.

SB 1 was litigated before the Illinois Supreme Court and struck down on May 8, 2015 for violating the Illinois state constitution's pension clause, which states that government pension benefits "shall not be diminished or impaired."

Sponsored in the Senate by Daniel Biss (D-9, Skokie)

and Minority Leader Christine Radogno (R-41, Lemont). Sponsored in the House by Speaker Michael Madigan (D-22, Chicago), House Republican Leader Rep. Jim Durkin (R-82, Burr Ridge), Asst. Majority Leader Elaine Nekritz (D-57, Buffalo Grove), and Darlene Senger (R-41, Naperville).

Passed the Senate March 20, 2013. Passed the House May 2, 2013. Signed by Gov. Pat Quinn (D) December 5, 2013.

#### SB 26 -- Quinn's Mental Health Shenanigans

Implements the Affordable Care Act (ACA) in Illinois by expanding Medicaid to individuals whose income is at or below 138% of the Federal poverty level. This expansion will result in the largest increase in mental health funding in the state since the enactment of Medicaid decades ago.

Sponsored in the Senate by David Koehler (D-46, Peoria) and Daniel Biss (D-9, Skokie) and in the House by Elizabeth Hernandez (D-24, Cicero) and Patrick J. Verschoore (D-72, Rock Island).

Passed by the Senate February 28, 2013. Passed by the House May 27, 2013. Signed by Gov. Patrick Quinn (D) July 22, 2013.

#### SB 274 — ILGA's Financial Protection Racket

During the final day of the spring legislative session, the Illinois General Assembly exempted their own budget from the normal appropriation process. This bill prohibits reductions to the salaries and operating expenses of legislators for subsequent sessions, even without passing an annual appropriation in the state budget. This new law also nearly eliminates the governor's role in rejecting or approving the legislature's budget.

Sponsored in the Senate by President John J. Cullerton (D-6, Chicago) and President Pro Tempore Don Harmon (D-39, Oak Park). Sponsored in the House by Speaker Michael Madigan (D-22, Chicago) and Barbara Flynn Currie (D-25, Chicago).

Passed the Senate April 10, 2014. Passed the House May 30, 2014. Signed by Gov. Pat Quinn (D) June 30, 2014.

# HB 3794 — 2014 Billion Dollar Construction Boondoggle Bill

Appropriates \$1.1 billion from Illinois taxpayers to fund unnecessary construction of government roads and bikeways, rest areas, sanitary facilities, and for the "preservation of natural beauty." In the mistaken belief that government can stimulate the economy by diverting taxpayer dollars to costly infrastructure projects, Illinois taxpayer's hard-earned dollars are funneled into the coffers of corporate cronies, government unions, and Illinois' political caste.

Sponsored in the Senate by Andy Manar (D-48, Bunker Hill) and Wm. Sam McCann (R-50, Jacksonville). Sponsored in the House by Luis Arroyo (D-3, Chicago).

Passed by the House May 29, 2014. Passed by the Senate May 31, 2014. Signed by Gov. Pat Quinn (D) July 22, 2014.

## **ANTI-TRANSPARENCY**

# HB 3796 — The Illinois Anti-Freedom of Information Act (FOIA)

This legislation makes successful FOIA requests more difficult. Redefines "voluminous request," giving government bodies more time to fulfill a request and more latitude to deny requests by pointing citizens to the Internet. Makes it much easier for government bureaucrats to appeal to "hardship" in order to avoid producing documents citizens have a right to see.

Sponsored in the House by Ed Sullivan, Jr. (R-51, Mundelein), and Robert Rita (D-28, Blue Island). Sponsored in the Senate by Michael E. Hastings (D-19, Matteson), Pamela J. Althoff (R-32, McHenry), and Pat McGuire (D-43, Crest Hill).

Passed by the House May 27, 2014. Passed by the Senate May 30, 2014. Vetoed by Gov. Pat Quinn (D) on June 27, 2014.

**Override of HB 3796 veto** — On December 3, 2014, both chambers of the General Assembly overrode Gov. Quinn's veto of HB 3796, effective December 8, 2014 as Public Act 98-1129.

A constitutional amendment that is fair to taxpayers, as well as government employees, must be approved in 2016 to deal with Illinois' lavish and insolvent government pension system.
