Dear Governor Daniels,

I am Vice President of Taxpayers United of America, one of the largest taxpayer organizations in the U.S. On behalf of taxpayers everywhere, I commend you for the exceptional job you have done reviving the Indiana economy by slashing government spending and balancing the budget.

Last year we travelled to many states, researching and publicizing the lavish pensions received by retired government employees. In many cases, we found annual government pensions to be higher than actual salaries in the private sector!

In response to our FOIA requests, we have generally received the information requested, including the "Top 100" government salaries and "Top 100" government pensions. The degree of cooperation has varied from state-to-state. Some states have shown a cooperative attitude, while others have given us the requested data only after repeated requests.

Surprisingly, the bureaucrats who have shown the least cooperative attitude are those in Indiana. This is surprising in view of the bold statement of public policy contained in IC 5-14-3-1, regarding access to public records, viz, : "...all persons are entitled to full and complete information regarding the affairs of government..."

Despite this stated policy, some data of great importance to taxpayers is simply not available. The Communications Director for the Indiana Public Retirement System stated, "We are only allowed to give information regarding a person's name and their years of service in the fund. Anything else is prohibited by law for us to release".
