3. COLA is officially none for 3 years, 2% 4,5,6 then 3% 7,8,9 then 3.5% 10,11,12 then 4% 13,14 then 5% after.

However there is an adjustment made if the retirement at any given year exceeds what the accumulated CPI would be for the years retired so 3% as an average has been used.

4. Maximum 90% if they started before 1985, 75% after 1985.
